TERMS AND CONDITIONS

1) Duration: The Aerodrome & Heliports Expo will take place from 11-13 June 2020. The exhibition will be open from 9am until 5pm daily. The right to alter times, for whatever reason, is reserved.

2) Exhibitor Booking: Application to reserve exhibit space shall be made with this form, which must be fully completed and signed with a legally binding signature, to be submitted without delay to AvBuyer Events Ltd. The signed application form is binding.

2.1) Stand sharing is not allowed without the prior written consent of the organiser.

3) Sales from Stand: Is confined to products as mentioned in your application, over-the-counter sales are permitted. However, food and drink may not be sold by any exhibitor.

3.1) Liquid gas equipment, flammables, explosives, chemicals or any harmful or noxious substances: Must not be exhibited or stored on your stand.

4) Booking and Assignment of Stands: Will be allocated on a first come first served basis. Stand allocation can only be based on the information stated in the application form.

5) Cancellation: In the event of an Exhibitor wishing to withdraw from the Exhibition, in whole, after the contractual date (as defined in paragraph 'Terms of Payment'), Exhibitor shall give written notice of such withdrawal to the Organisers. No obligation whatsoever shall be placed upon the Organisers to refund any monies previously received from such Exhibitor. The Exhibitor shall be liable to make all monies due to the Organisers pursuant to the payment terms (as defined in paragraph 'Terms of Payment'). For the purpose of clarification an Exhibitor upon cancelling their Exhibition space shall not be refunded any amounts already paid and shall be liable for any amounts still outstanding for the Exhibition space.

6) Stand Construction/Technology: Stands exceeding the standard the height of 2.4 metres or special constructions must be submitted with the stand plans to the organiser for approval. The relaying of music from exhibition stands or the use of audio-visual resources using sound are also subject to approval. Floor covering for all exhibition stands is absolutely compulsory.

6.1) The entire risk and responsibility with regard to exhibits, machinery, plant and equipment of each exhibitor, including liability for accidents due to the handling and housing of such exhibits, the attendance on, and the management thereof, the conduct of the stand generally and all consequential and other injury or loss arising from the aforementioned matters shall be borne by the exhibitor. Any exhibitor or stand contractor or staff employed by him, who willfully or accidentally defaces another exhibitor's stand/site will be held responsible for making good or be liable to defray the cost thereof.

7) The exhibitor shall not do or omit to do any act that may jeopardise the current insurances or licences of the organisers in connection with the exhibition place or the exhibition or any terms thereof and shall comply with any law, governmental regulation, direction, restriction, local by-laws or other provisions from time-to-time in force. The exhibitor shall keep the organiser indemnified against any loss, damage, expenses, fines penalties or cost arising directly or indirectly as a result of doing or omitting to do any such act or compliance as aforesaid.

8) Exhibitors participate at their own risk in every respect, including that from water, fire and or damage to or loss of stands, furniture, fittings or packing cases from any cause and at any time exhibits are in transit whether to or from the exhibition site. It is a condition binding upon the exhibitor that he indemnifies the organisers, their servants or agents against liability in respect of injury to himself, his servants, agents or other persons arising from such participation and also in respect of damage to goods or property used in connection therewith, whether or not such goods or property be owned by the exhibitor or even though such injury or damage be caused by the negligence of the organiser, their servants or agents. The exhibitor will further indemnify the organiser in respect of any loss or damage to the premises or property thereon arising from the participation by the exhibitor.

9) All exhibitors shall carry a public liability insurance of not less than £2,000,000 for aircraft and £1,000,000 for non-aircraft. All must submit a copy of the insurance policy and premium receipt. All exhibitors exhibiting aircraft shall carry minimum third party and passenger liability insurance in accordance with the European Parliament Regulation (EC) No 785/2004 that is now law in the UK.

10) The organisers shall not be liable in respect of any claim for compensation or refund, or for any claim with regard to, or arising out of, or connected with, the exhibition or the holding, cancellation or curtailment thereof, for any reason beyond the reasonable control of the organisers.

11) In the event of cancellation, for any reason whatsoever, of the exhibition, the organiser shall not be under any liability whatsoever in respect of any expenditure, or liability, or loss incurred by exhibitors and shall be entitled to retain sums paid by exhibitors considered by the organisers to be necessary to cover the expenses incurred in connection with the exhibition.

12) Violation of the exhibition terms and conditions gives the organiser, the right, to exclude any person, firm or corporate body from the exhibition. Any unfair, dishonest or unseemly conduct either at, or in connection with the exhibition gives the organiser the right to close your stand immediately, and to clear it off without requiring court action. This applies in particular to cases of advertising in contravention of the law, against good morals or directed against the purposes of the exhibition, and in case of advertising for political or ideological purposes.
